DIRECTIONS FOR USE

Use with low water volume (1 to 2 gal/ 1000 sq. ft) and allow to dry on turf to get maximum foliar absorption (3-6 hours before irrigation). For best results apply early in the morning or late evening.

TURF APPLICATION RATE

Apply MP-XTM at 1 lb. (1 scoop) to 2 lbs. (2 scoops) per acre bi-weekly. Increase/decrease rate accordingly to frequency of application.
