AgroFuze Mo-Zinc Xtra SC is an aqueous based micro-nutrient formulation intended for use as a seed applied nutrient. It is intended for use on cereals, legumes, and corn. Do not use with any phosphate containing fertilizers. Can be applied in combination with fungicides and pesticides. Compatibility and stability testing is recommended.

RATE OF APPLICATION

Wheat, barley, oats, rye and trit: 2-8 oz/cwt
Dry beans, peas, lentils, garbanzos, and large seed vegetables: 2-8 oz/cwt
Corn: 4-8 oz/cwt
Other crops: Consult your HydroGro Representative

SEED TREATMENT RECOMMENDATIONS

Dilution: If necessary, dilute with water to maintain 40% water ratios.

Treatment Method:

Tumbler: Slowly pour AgroFuze Mo-Zinc Xtra SC, ensuring uniform application. Seeds should be tumbled steadily through the application process.

Spray Application: AgroFuze Mo-Zinc Xtra SC can be used with standard seed treatment application equipment. Ensure uniform application.
